- Surveillance on CWD with antlerless disease with collars shows an increase in CWD from last year.
- Wildlife Crossings House Resolution 87 passed the on May 23rd to conduct a study in PA on the status management and benefits of conservation crossings to be constructed on roadways in PA.
- Some discussion on the new process of purchasing hunting license online.

Pollution – Mike Harcher

• The PFA "forever chemicals" put on gardens and farmer fields can be toxic. Biosolids found the parts per million are higher than what is allowed. EPA is working on this; however, there are no regulations set at this time.

- Satellites and drones use infrared to monitor air pollution in PA by looking for leaking gas wells, etc. Looking around industrial plants.
- Incident in Pittsburgh 9-mile stream run that came from a municipal water plant noted to have changed colors. It is now clearing and there is no report of it harming fish or people.

Speeches were given by the rally hosts, House 2A Caucus Chair, <u>Rep. Abby Major</u>, and the Senate 2A Caucus Chair <u>Sen.</u> <u>Chris Dush</u>. Special guest speakers were Karise and Jerel Crew, fellow Pennsylvanians, educators, leaders in the PA Chapter of the National African American Gun Association, and founders of <u>That Gun Talk LLC</u>.

There was a slight drizzle, and there were massive audio issues with the PA system, that were never resolved, but the speakers used their "outdoor voices" and all in attendance heard their messages of freedom.

That day, FOAC-ILLEA leadership and other concerned gun owners met with various elected officials and staff members to further the cause of freedom and our US and PA Constitutions.

What will it take for Pennsylvania gun owners to get involved?

Perhaps if the legislature passed an AR-15gun ban, would that motivate people to make a showing and get involved? How about a red flag law? Maybe a magazine capacity restriction law? How about a gun confiscation act? Maybe mandatory storage laws? Perhaps mandatory training to BUY a firearm? What about a law that limits the number of guns and ammo you can buy each month? How about a law that lets every individual town and municipality make their own laws about guns and ammo? Oh wait, I know, what if the government tried to re-write or repeal the 2A of the US Constitution and Article 1 Section 21 of the PA Constitution... I bet gun owners would get active THEN, RIGHT???

Hey... guess what.... There are elected officials and appointed officials in all branches of government trying to do all of those things RIGHT NOW!!!!!!!!
